The Credit Union is authorized to recognize any of the signatures below for transactions of any business on any account on which that party is named as an owner.

You hereby revoke any proxy executed by you and hereby appoint the Board of Directors of this Credit Union as your proxy to represent the undersigned and act in the name, place and stead of the undersigned at any meeting of the members of this Credit Union; and the Secretary of this Credit Union, or his/her, is directed to vote as proxy when directed by and in the manner determined by the majority of Directors present at any such meeting. This proxy shall not be effective during any meeting of the members of this Credit Union whereat the undersigned is present. This proxy shall remain in force and in effect for three years from the date of this execution as set forth above, or such longer period of time as may be permitted by law. The Credit Union may renew this proxy for an additional period of time as permitted by law with proper advance notice. You may cancel this proxy at any time, with written notice to the Credit Union.
